Sequentially, the profit was higher than ₹5,860.80 crore in the previous quarter.

For the fiscal April to March 2022, IOC posted the highestever revenue by any Indian corporate at ₹7.28 lakh crore or \$96 billion (standalone). Consolidated revenue, after including earnings of subsidiaries like CPCL, came at ₹7.36 lakh crore. Reliance Industries had earlier this month reported ₹7.92 lakh crore revenue for fiscal FY22. This was claimed to be the highest ever by an Indian company but it included GST, which the company collected on behalf of the government on sale of products and is obligated to transfer to the government.

IOC revenues do not contain the GST element.

"IOC reported the highestever revenue from operations by any corporate during FY22," director-finance company Sandeep Gupta said.

For the full fiscal 2021-22 (April 2021 to March 2022), IOC reported the highest ever net profit of ₹24,184.10 crore, up from ₹21,836.04 crore last year. "This is the highest profit by IOC ever," he said.

For FY22, Reliance had reported a net profit of ₹60.705 crore.

AS per the filing, IOC made record margins on turning crude oil into fuel but they were wiped away by lower cracks on naphtha and losses on petrol, diesel and domestic LPG sales.

ended in March due to lower income. Its net profit stood at ₹480.94 crore in the year-ago period, the company said in a regulatory filing.

Total income declined to ₹1,652.13 crore during the fourth quarter of the last fiscal from ₹1,906.59 crore in the corresponding period of the previous year.

Net profit rose to ₹1,500.86 crore during the last financial year from ₹1,093.61 crore in the 2020-21 fiscal. Total income rose to ₹6,137.85 crore in 2021-22 from ₹5,944.89 crore in the previous year.

In a statement, DLF said that its sales bookings more than doubled to ₹7,273 crore. Net debt at the end of fiscal stood at ₹2,680 crore, a 46% y-o-y reduction.

Housing demand continues to exhibit a structural upswing across segments and geographies, it said.

The company had clocked a net profit of ₹97.45 crore during the year-ago quarter, it said in a BSE filing.

Its total income during the quarter under review rose to ₹1,682.72 crore ₹1,650.40 crore in the yearago period. Expenses stood at ₹1,379.90 crore, as compared

to ₹1,474.27 crore a year ago. The company in a statement said the financial numbers and toll collection numbers are clear indication of the economic activity regaining pace across the nation, post relaxation from the lockdown imposed due to the pandemic.

Chairman and managing director Virendra D Mhaiskar said, "We witnessed a robust growth in collections across projects as the pandemic related restrictions were relaxed and farmer's protest was called off." - PTI
