BANK OF BARODA on Friday said it has raised over ₹971 crore by issuing Basel III compliant bonds.

The bank issued Basel III compliant tier II bonds of face value of ₹10 lakh each amounting to ₹971.50 crore. The unsecured, redeemable

bonds carry a coupon rate of 8.42%, Bank of Baroda said in a regulatory filing. The issue opened Thursday and closed the same day, it added. As many as 17 allottees were given the bonds under the issue.

Basel III is an international regulatory framework with a set of reforms to improve the regulation, supervision and risk management within the banking sector.

To comply with global Basel-III capital regulations, banks need to improve and strengthen their capital planning process.

These norms are being implemented to mitigate concerns on potential stresses on asset quality and consequential impact on performance and profitability of banks.

# Forex reserves rise by \$932.8 m to \$393.72 bn

THE COUNTRY'S FOREIGN exchange reserves increased by \$932.8 million to \$393.718 billion in the week to November 30, mainly due to a rise in foreign currency assets, according to RBI data.

In the previous week, the reserves had dropped by \$ 795 million to \$392.785 billion.

In the reporting week, foreign currency assets, a major component of the overall reserves, jumped by \$787.9 million to \$368.487 billion, as per the RBI data.

Expressed in US dollars, for-eign currency assets include the effect of appreciation or depreciation of non-US cur-rencies such as the euro, pound and yen held in the reserves.


