# Dad of Indian kid: I 'dumped' body

 $T^{\text{wo days after the discovery}}_{\text{of a child's body in a culvert}}$ in Richardson, Texas, the police on Tuesday confirmed that it was indeed of the missing threevear-old Indian-American Sherin Mathews, who had been adopted by her NRI foster parents from an orphanage in Bihar two years ago.

Even before completion of the identification process, the police on Monday arrested Sheryn's adoptive father, Wesley Mathews, and charged with causing "Injury to a Child", a first-degree felony punishable by life or from five to 99 years in prison. The arrest came about after the 37-year-old Mathews admitted to police that he "dumped" the toddler's body near his home after she choked on her milk while he "physically assisted" her.

Mathews, who was originally arrested on October 7 and let off on a bond of \$2,50,000 a

day later, is now being held in the Richardson Central Jail, with his new bond set at \$1 million.

Richardson police officials said on Tuesday that the Dallas Medical Examiner's Office used dental records to confirm the identity of the body that was found in the culvert on Sunday. Her cause of death has not been determined yet and police have not said whether or not they suspect foul play, the Dallas Morning News reported.

Mathews voluntarily went to the police on Monday, along with his attorney, and offered a new account of what happened the night of October 7.

Citing an arrest warrant affidavit, Fox News reported that Mathews told police that he and the girl were in the house's garage when she refused to drink her milk. She allegedly wouldn't listen. She then began drinking and the father stepped in to "physically assisted" drinking the liquid. Sherin began choking, coughing and breathing slowly at some point, according to the affidavit.

Mathews told the police that he couldn't feel a pulse on his daughter and believed she died. He then said he removed the toddler's body from the house.

### | Xi emerges as China's most powerful leader since Mao

Beijing: President Xi Jinping on Tuesday attained iconic status enjoyed by modern China's founder Chairman Mao Zedong, with his name and ideology enshrined in the Constitution of the ruling CPC, as he secured a second fiveyear term with sights firmly set on an unprecedented third.

The once-in-five-years Congress of the Communist Party of China (CPC) on its final day approved Xi's ideology to be written into its Constitution, which is in addition to the title of "core leader" conferred on him last year that analysts say enhances his leadership status above other leaders of the party.

Till now, only the thoughts of Mao and his successor Deng Xiaoping were enshrined in the Constitution of the world's longest ruling Communist Party, interpreting the complex doctrine of Marxism with Chinese characteristics.

The thoughts of Deng, China's reformist leader, were added posthumously. CPC historians compare 64-year-old Xi with party founder Mao. The thoughts of two of Xi's predecessors, Jiang Zemin and Hu

Jintao, were mentioned in the Constitution but not their names. This makes Xi only the third leader to have his thoughts on governance enshrined which will now be part of school textbooks all over China.

But Xi, who is regarded as the most powerful leader heading the party, presidency and the military in the last five years did not have his way in the Congress as he had to settle for a compromise to let his closest aide, Wang Qishan, 69, to retire in an apparent trade off with other powerful factions in the party to get his name enshrined in the Constitution.

The name of Wang, who headed the massive anti-corruption drive targeting "tigers and flies" in the party in which over a million officials punished, was not found in the 204strong list of elected members of the Central Committee, the top most policy body of the CPC. The "election" to the Central Committee held in a most secretive functioning of the party, is essential to get into the 25-member Politburo and the seven-member Standing Committee which virtually rules the country.

#### **Jailed Hong Kong activist Joshua Wong** released on bail

Hong Kong: Jailed democracy activists Joshua Wong and Nathan Law were released on bail on Tuesday pending an appeal against convictions for their role in the 2014 Umbrella Movement protests.

The jail sentences handed down by the city's Court of Appeal in August came amid mounting fears that Beijing is tightening its grip on the semiautonomous city and that rule of law is being compromised.

Wong, 21, who became the face of the mass prodemocracy protests while still a teenager, was jailed for six months while Law, 24, was

imprisoned for eight months. They were granted bail at the Court of Final Appeal until November 7, the first appearance in the appeal proceedings.

A third activist, Alex Chow, who was jailed for seven months alongside Law and Wong, was not part of Tuesday's hearing. AFP

#### Brussels: European Council President Donald Tusk on Tuesday said the future relationship between the UK and the European

Union (EU) was dependant on the former and suggested that Brexit could be halted. Speaking at the European Parliament in Strasbourg, Tusk stressed the importance of unity among the remaining 27 EU member states irrespective of which way negotiations go, reports Efe news. "It is in fact up to London how this will end: with a good deal, no deal or no Brexit," said Tusk. He said the bloc could take on "every scenario as long as we are not divided." It was not the first time since the Brexit process began that the top official has floated the possibility of the UK remaining in the EU; he touched on it after an FU leaders summit in June. drawing inspiration from John Lennon's song "Imagine".


