World champion's father Ramana has gone the extra mile to protect her as training resumes after lockdown amidst rising cases

PV RAMANA, father of the world champion PV Sindhu, said he has categorically told national coach P Gopichand that no one beyond coach Park Tae Sang, Gopichand and him are to enter the academy training hall till Sindhu is on court, once the camp resumes. Ramana said the added caution was necessary after fellow shuttler Sikki Reddy and physio Kiran Challangundla tested Covid-positive on Thursday.

"I have told Mr Gopi that once we resume and Sindhu's session is from 6-8.30 am, I'll come in advance at 5.30 and personally check how the court is sanitised. We'll leave by 8.30. He can start the next session at 9. But if anyone enters the hall in that time allotted to Sindhu, then from the next day, we'll not go for training," Ramana said.

He added that he had told the coach to hold exclusive sessions for Sindhu, but Gopichand had stressed that he was dutybound to pay attention to others, including World championship medallist Sai Praneeth and former No 1 Kidambi Srikanth.

While Sindhu had an exclusive session to herself from August 7 when the camp started, a slight overlap with other campers coming in from 8 am and getting ready to train on other courts had annoyed her father.

While 11 camp members underwent a second RT-PCR test on Friday, having come in contact with the infected duo over the course of training and a gym session, Ramana insisted Sindhu hadn't practised with others, and wouldn't need a test so soon after the one carried out on August 11, results

of which came the next day.

Sindhu will continue her physical conditioning and gym work at the Suchitra Academy. "They have a lot of manpower there so every piece of gym equipment is wiped clean with Dettol liquid before she arrives. So in the evening, two hours are exclusively for Sindhu," he said.

THERE IS little in modern football that can truly be described as a fairytale romance but RB Leipzig's journey from Germany's regional league system to the last four of the Champions League in just 11 years surely gets close.

The 2-1 victory over Atletico Madrid at the Estadio Jose Alvalade on Thursday sent Leipzig, from the former East Germany, into the semifinals where they will face Paris St Germain Not even the most ambitious of those involved in the creation of the club in 2009 could have imagined their team being 90 minutes away from the biggest game in European club football. The fact that the rapid rise has been bankrolled by Austrian energy drink company Red Bull, after its billionaire owner Dietrich Mateschitz found a way to get around the Bundesliga's restrictions on companies owning a majority stake in clubs, has left Leipzig unloved by many in German football.

But their success is about much more than the finances of Mateschitz, who took over amateur club SSV Markranstaedt in 2009 and turned them into RasenBallsport Leipzig - literally Lawn Ball Leipzig.

The name allowed them to use the company's RB initials. The 88th minute winning goal came from American substitute Tyler Adams, a player who started out in the Red Bull academy in New York as a 12-year-old before coming through the ranks. He played for MLS's New

York Red Bulls before joining Leipzig last year. Red Bull also own Austrian club RB Salzburg and have a presence in Brazil.

Ramana was sceptical about the Thomas and Uber Cup (TUC) going ahead in October in the current scenario, and said they would wait until closer to the date before taking a call on travelling.

"Maybe individual events like French or Denmark Open are different where she goes, plays and comes back, but not with the team. But TUC is a team event with so many countries. It's a risk. Unless there's a vaccine, I don't know if we need to risk traveling to Paris and Denmark this year. But we have given an acceptance that if points are going to be added for Olympic qualification, we might consider. Otherwise why take a risk, what's the hurry?" he said.

Rizwan shines on a gloomy day as Pakistan frustrate England

PAKISTAN EMERGED from the second day in better shape than they might have anticipated, on the back of a combative unbeaten 60 from Mohammad Rizwan and some shabby bowling from England. When bad light stopped play, half an hour into the final session, Pakistan were 223/9 in 86 overs.

In the conventional sense, the score is incompetent. But given the amount of swing the surface generated, and the fast-bowling ammo at their disposal, Pakistan would be sufficiently pleased with their comeback. Even 200, at one stage, had looked dreamy.

When Stuart Broad nailed Babar Azam with a nearunplayable delivery, Pakistan were truly under the weather. They were 158 for 6 and in danger of being bowling out imminently. But in these difficult moments, Pakistan habitually summon an unseemly streak of defiance and energy. Rizwan embodied that spirit.

The 28-year-old is a pugnacious batsman with a sturdy technique and admirable game sense. Ever keen for a scrap, like the prototypical Pakistani wicket-keeper batsman, he altered his approach according to the aptitude of his partner. With Azam, he was cautious and eager to rotate the strike, with Yasir he started to embrace a few risks, and with the tailenders, he began to manufacture strokes. Like a cheeky little ramp and slash cut off a Sam Curran over, before he smeared Chris Woakes through covers.

Down with the last man, Naseem Shah, he threw caution to the wind, clattering Broad through covers and running every run frantically. Thus with the last four, he added 65 valuable runs in extremely trying conditions for batting. Rizwan's three partners collected just eight runs, but they ate up 56 deliveries and lend efficient support to the 'keeper-batsman. It was a masterclass on shepherding the lower-order batsmen.

What would anger England, even more, is that the conditions could not have been more ideal for swing bowling – the floodlights shimmered all day long and the skies were heavily overcast. The ball not only seamed off the pitch but swung nicely in orthodox fashion throughout the day. If it was not a lightning-fast surface, there was adequate carry through. But the conditions needed harnessing, which England managed only in bursts.

In the first session that lasted barely an hour, Azam and Rizwan batted vigilantly to stave off an early detonation. A bit of resistance was expected from Pakistan's last pair of designated batsmen, but England's bowling was wayward and inconsistent. with batsmen allowed the luxury of leaving too many deliveries and those that they were not full enough to tempt the drive. As much as 52 percent of deliveries

landed in the good-length zone, providing ample time for the batsmen to judge the deviation.

Pakistan, especially Azam, batted with calm authority. His clarity of method stood out — he kept leaving outside the off-stump and forced the bowlers to shift their line into his body. His judgement of swing was immaculate, as was the fluidity of his feet. But a big score still eluded him, as England began to probe fuller lengths after lunch and reaped instant reward. Broad's fuller-length delivery straightened just enough to square Babar up and shave the outside edge, ending a stubborn stand.

Shortly, Anderson winkled out Yasir Shah with another full delivery, and the inexperienced lower order was waiting to be wiped away. But guided by Rizwan, they not only frustrated the bowlers but also nudged their total past 200, which had seemed inconceivable at one stage. It was a bizarrely wayward day for England's support cast bowlers. The usually disciplined Woakes, whose methods seemed tailor-made for the pervading conditions, erred too often to leg-side, provoking furtive glances from 'keeper Jos Butter. Curran seemed to have lost his ability to curl the ball back into the right-hander, which had made him a deadly proposition in the series against India two years ago.

In the end, it was down to the grand old firm of Broad and Anderson to resuscitate them. Anderson seemed to have put an indifferent year behind him, while Broad continued his rich vein of form, picking three or more wickets for the seventh time in succession. Both, though, would readily admit that they had laid ideal swing-bowling conditions to waste.




जलभराव में फंसी गाड़ी, शीशा तोड़कर बाहर निकले पुलिसकर्मी
